## SUMMARY

- AS 1: **Speaking** – Presentation and conversation (70 marks), approx 13 mins, 35% of AS, 17.5% of A Level, available January and Summer
- AS 2: Total 2 hrs 45 mins (130 marks), 65% of AS, 32.5% of A Level, available January and Summer  
**(Section A) Listening** – Students answer two questions based on two passages recorded on individual CDs, 30 minutes (30 marks)  
**(Section B) Reading** – Two reading comprehension questions based on one text, 1 hr 15 mins (30 marks), translation into English (20 marks)  
**(Section C) Writing** – Students must write an essay response to stimulus text, 1 hr (50 marks)
- A2 1: **Speaking** – Discussion based on societal theme and conversation (70 marks), approx 15 mins, 17.5% of A Level, available Summer only
- A2 2: Total 3 hrs (130 marks), 32.5% of A Level, available Summer only  
**(Section A) Listening** – Students answer two questions based on two passages recorded on individual CDs, 35 mins (30 marks)  
**(Section B) Reading** – Students answer three questions based on two texts, 1 hr 25 mins (30 marks), translation from English into the target language (20 marks)  
**(Section C) Writing** – Students must answer one essay response based on a literary text, 1 hr (50 marks)
